TO COMBAT CAT OVERPOPULATION THROUGH HUMANE TNR (TRAP-NEUTER-RETURN). BY REDUCING THE OVERALL CAT POPULATION, FEWER CATS WILL NEED TO BE EUTHANIZED IN SHELTERS FOR SPACE, AND THERE WILL NOT BE AS MANY KITTENS DYING ON THE STREETS. THERE ARE NOT ENOUGH ADOPTIVE HOMES TO SUPPORT THE GROWING CAT POPULATION.
